Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs. 40,000 (In Words Rupees Fourty Thousand only), which shall be valid for 30 days beyond the validity period of the bid i.e. 75 days.
