- 5. The Sealed Quotations will be opened in the presence of Bidders authorized representatives who choose to attend at 2:30 P.M. on 2080/02/10 at the Nepal Rastra Bank, Dhangadhi Office. Quotations must be valid for a period of 45 days from the last date of submission of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee which shall be valid for 75 days from the last date of submission of Sealed Quotations.
