4. Sealed bids must be submitted through e-GP system i.e www.bopatra.gov.np/egp on or before 22-05-2026 13:00. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 22-05-2026 14:00 at the office of Nepal Rastra Bank Birgunj Office, Parsa Madhesh, Pradesh Nepal.
6. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security mentioned as per the above table, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to attach the Cash Security, the cash should be deposited in Deposit Account No. [1709999-011-004-524] at Nepal Rastra Bank Birgunj Office and attach the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
