5. Sealed bids must be submitted to the Nepal Rastra Bank, Birgunj Office, Adarshanagar through e-GP system i.e. www.bolpatra.gov.np on or before 12:00 Noon on 2082/04/01 Bids received after this deadline will not be accepted.
6. The bids will be opened in the presence of bidders' authorized representative who choose to attend at 2:00 PM on 2082/04/01 at the Nepal Rastra Bank, Birgunj Office, Adarshanagar. Bids must be valid for a period of 45 days (i.e. 2082/05/15) after bid opening and must be accompanied by a bid security amounting to minimum of Rs. 40,000.00 (Rupees Forty Thousand only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 2082/06/14) If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1709999/011-004-524 at Nepal Rastra Bank, Birgunj Office, Adarshanagar and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and/or submission date falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
