- 5. Quotations must be valid for a period of 45 days from the last date of submission of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, which shall be valid for 75 days from the last date of submission of Sealed Quotations (that is, till 2077/12/17).
- 6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No.1709999-011-000-524 at Nepal Rastra Bank Birgunj office and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotation shall be opened in the presence of supplier's authorized representatives who choose to attend **at 2:00 PM on 2077/10/01** at the Nepal Rastra Bank, **Birgunj office.**
