4. Sealed Quotations must be submitted to Nepal Rastra Bank, Birgunj Office on or before **12:00 Noon on 2077/10/01**. Quotation received after this deadline shall not be accepted.
5. Quotations must be valid for a period of **45 days** from the last date of submission of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, which shall be **valid for 75 days** from the last date of submission of Sealed Quotations (**that is, till 2077/12/17**).
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No.**1709999-011-000-524** at Nepal Rastra Bank Birgunj office and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. Sealed Quotation shall be opened in the presence of supplier's authorized representatives who choose to attend **at 2:00 PM on 2077/10/01** at the Nepal Rastra Bank, **Birgunj office**.
8. If the last date of purchasing, submission and opening falls on a public holiday then the next working day shall be considered the last day.
