  - c) Cash Deposit Voucher received upon payment of a non-refundable fee of *NPR. 1,000.00 (One Thousand Rupees Only)* deposited at **Nepal Rastra Bank, Janakpur Office** before deadline for the submission of sealed bids, during office hours, in the following account:

- 4. Sealed bids must be submitted to the **Nepal Rastra Bank**, **Janakpur Office** by *hand* on or before **12:00 Noon on 2080/06/09.** Bids received after this deadline will be rejected.
- 5. Sealed bids must be accompanied by a **Cash Security or a Bank Guarantee** amounting to a minimum of bid security amount as mentioned in the above table.
- 6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No.1609999-011-001-524 at Nepal Rastra Bank, Janakpur Office and the receipt of the cash deposit must be submitted along with the Sealed Quotation. Or the bidders can submit an unconditional bank guarantee from Commercial bank or any Financial Institution eligible to issue Bank Guarantee as per prevailing Law.
- 7. Bids must be valid for a period of **45 days** from the last date of submission and the Cash Security or Bank Guarantee shall be **valid for 75 days** from the last date of submission.
- 8. Bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 2:00 PM on 2080/06/09 at the Nepal Rastra Bank, Janakpur Office.
- 9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date.
