5. Sealed bids must be submitted to the office **Nepal Rastra Bank, Nepalgunj Banke** by hand/courier on or before **12:00 PM on 2083/06/06**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12:30 PM on 2083/06/06** at Nepal Rastra Bank Nepalgunj Banke. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security amounting to a minimum of **NRs.2,40,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
