- 5. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 12:30 P.M. on 2080/11/22 at the Nepal Rastra Bank, Nepalgunj Office, Banke.
- 6. Bids must be valid for a period of 45 days from the last date of submission of Sealed Quotations and must be accompanied by aforementioned Cash Security or Bank Guarantee which shall be valid for 75 days from the last date of submission of Sealed Quotations.
- 7. If bidder wishes to submit the Cash Security, it shall be deposited in Sundry Creditors Account No. 2109999/011/002/524 at Nepal Rastra Bank, Nepalgunj Office, Banke and the bidder must submit the cash receipt along with Sealed Quotation.
- 8. If the last date of purchasing and/or submission date falls on a public holiday, the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
