Nepal Rastra Bank, Nepalgunj Office invites electronic bids from Nepalese eligible bidders for the Renovation of Toilets at Staff Quarter and VIP Guest House at Nepal Rastra Bank, Nepalgunj Office under National Competitive Bidding procedures. The estimated amount for the works is Rs.48,83,166.62

Bidders should deposit a **non-refundable fee of** *Rs.3000/-* in the account as specified below and the scanned copy of bank deposit voucher should be uploaded by the bidders at the time of electronic submission of the bid. - 4. Pre-bid meeting shall be held at *Nepal Rastra Bank*, *Nepalgunj Office* at 2:00 PM on 10-07-2024
- 5. Electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 PM on 24-07-2024. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 PM on 24-07-2024 at the office of Nepal Rastra Bank, Nepalgunj Office. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Rs. 100,000/-, which shall be valid for 30 days beyond the validity period of the bid (i.e. 22-11-2024)
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 8. Nepal Rastra Bank reserves the right to accept or reject, wholly or partly any or all the bid without assigning any reason, whatsoever.
