- 5. Sealed bids must be submitted to the Nepal Rastra Bank, Pokhara office by *hand* on or before **12:00 Noon** on **2080/09/12**. Bids received after this deadline will not be accepted.
- 6. Sealed bids must be accompanied by a Cash Security or a Bank Gaurantee equivalent to a minimum of bid security amounts as mentioned in the above table.
- 7. If bidder wishes to submit the Cash Security, the cash should be deposited in

- and the receipt of the cash deposit must be submitted along with the Sealed Quotation. The bidders can also submit an unconditional bank gaurantee from any commercial bank or financial institution eligible to issue the bank gaurantee as per prevailing Law.
- 8. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at **12:30 Noon** on **2080/09/12** at the Nepal Rastra Bank, Pokhara Office. Bids must be valid for a period of 45 days from the last date of submission.
- 9. The bank gaurantee shall be valid for 75 days from the last date of submission.
- 10. If the last date of purchasing and/or for submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
