- 4. Sealed bids must be submitted to the Nepal Rastra Bank, Pokhara office by *hand* on or before **12:00 Noon** on **2080/08/27**. Bids received after this deadline will not be accepted.
- 5. Sealed bids must be accompanied by a Cash Security or a Bank Gaurantee amounting to a minimum of bid security amount as mentioned in the above table.
- 6. If bidder wishes to submit the **Cash Security**, the cash should be deposited in

- and the receipt of the cash deposit must be submitted along with the Sealed Quotation. Or the bidders can submit an unconditional bank gaurantee from Commercial Bank or any Financial Institution eligible to issue Bank Gaurantee as per prevailing Law.
- 7. The bids will be opened in the presence of Bidders' authorized representative who choose to attend at **12:30 Noon** on **2080/08/27** at the Nepal Rastra Bank, Pokhara Office. Bids must be valid for a period of 45 days from the last date of submission and the Cash Security of Bank Gaurantee shall be valid for 75 days from the last date of submission.
- 8. If the last date of purchasing and/or submission date falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The NRB reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
