- 4. Pre-bid meeting shall be held at Nepal Rastra Bank, Financial Information Unit, Baluwatar, Kathmandu on 2079/01/06 at 11:00 AM.
- 5. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Nepal Rastra Bank, Financial Information Unit, Baluwatar, Kathmandu, Nepal on or before 12:00 Noon on 2079/01/16.

- 6. Bids shall be opened in presence of Bidders' representatives who choose to attend on 1:00 PM on 2079/01/16 at the office of Nepal Rastra Bank, Financial Information Unit, Baluwatar, Kathmandu, Nepal.
- 7. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security mentioned above which shall be valid for minimum 30 days beyond the bid validity period (i.e. 2079/05/10).
- 8. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9. FIU reserves the right to accept or reject any bid and to annul the bidding process at any time prior to contract award, without thereby incurring any liability to bidders.
