- 5. Sealed Quotations will be opened in the presence of Suppliers' representatives who choose to attend at 12:30 PM on **2079/06/05.** at the Nepal Rastra Bank, Financial Information Unit, Baluwatar.
- 6. Sealed Quotations must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security amount mentioned above in table.
- 7. Bid security shall be valid for 30 days beyond the validity period of the bid.(i.e. 2079/08/19)
- 8. If bidder wishes to submit the Cash Security, the cash should be deposited in **Sundry Creditors** Account No 2409901/011/000/524 at Nepal Rastra Bank, Banking Office, Baluwatar and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
