- Sealed Quotation must be submitted to the Nepal Rastra Bank, Nepalgunj Office on or before 12:00 Noon, 2075/10/03. Quotation received after this deadline shall not be accepted.
- 5. Quotation must be valid for a period of 45 days from the last date of submission of Sealed Quotation and must be accompanied by Cash Security or Bank Guarantee amounting to Rs. 7,500.00, which shall be valid for 75 days from the last date of submission of Sealed Quotation.
- 6. If Bidder wishes to submit the Cash Security, the cash should be deposited in **Sundry Creditors Account No. 2109999/011/002/524** at Nepal Rastra Bank, Nepalgunj Office and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotation shall be opened in the presence of supplier's authorized representative who chooses to attend at 12:30 PM on 2075/10/03 at the Nepal Rastra Bank, Nepalgunj Office, Banke.
- 8. If the last date of purchasing and/or submission date falls on a public holiday, then the next working day shall be considered as the last date. In such a case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
