1. Nepal Rastra Bank has allocated funds from its own resources towards the cost of **"Interior Furnishing and Finishing Works for Newly Constructed Buildings of Nepal Rastra Bank at Thapathali, Kathmandu"** and intends to apply part of the funds to cover eligible payments under the Contract for "The Procurement of Interior Furnishing and Finishing Works for Newly Constructed Buildings of Nepal Rastra Bank at Thapathali, Kathmandu, NRB/WORKS/NCB/07/082/83". Bidding is open to all eligible as per Section V of bidding document.
2. Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu invites electronic bids from eligible bidders for the construction of Interior Furnishing and Finishing Works for Newly Constructed Buildings of Nepal Rastra Bank at Thapathali, Kathmandu under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 15,25,00,000.
 - b) Minimum Work experience of similar size and nature: NRs 6,10,00,000.
3. Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document. Bidder shall have to submit their bid electronically only.
4. 5. Bidder may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding non-refundable fee of NRs.10,000 in the account as specified below.

6. Pre-bid meeting shall be held at Nepal Rastra Bank Assets and Service Management Department, Baluwatar, Kathmandu at 11:00 AM on 20-July-2026.
 7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 30-July-2026. Bids received after this deadline will be rejected.
 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 P.M. on 30-July-2026 at the office of Nepal Rastra Bank Assets and Service Management Department, Baluwatar, Kathmandu. Bids must be valid for a period of 120 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Rs. 21,00,000.00 (In Words Nepalese Rupees Twenty One Lakhs Only), which shall be valid for 30 days beyond the validity period of the bid. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Account Name: EARNEST MONEY-DEPOSIT, Financial Management Department, Bank Name: Nepal Rastra Bank, Banking Department, Bank Address: Thapathali, Kathmandu, Account Number: 1109901-011-203-524 and submit the receipt of the deposited amount of cash along with the bid.
 9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
