1. **Nepal Rastra Bank** has allocated funds from its own resources towards the cost of the procurement of Supply, Delivery and Installation of Furniture and Fixtures for Newly Constructed Buildings at Nepal Rastra Bank, Baluwatar and intends to apply part of the funds to cover eligible payments under the Contract for **"The Procurement of Supply, Delivery and Installation of Furniture and Fixtures for Newly Constructed Buildings at Nepal Rastra Bank, Baluwatar"** (IFB No.: **NRB/GOODS/NCB/09/082/83**). Bidding is open to all eligible Bidders as defined in ITB Clause 4 (Eligible Bidders).
2. The **Nepal Rastra Bank** invites electronic bids from eligible bidders for **the Procurement of Supply, Delivery and Installation of Furniture and Fixtures for Newly Constructed Buildings at Nepal Rastra Bank, Baluwatar** under National competitive bidding – Single Stage Two Envelope procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
4. 5. Bidder submitting their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system **www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the cost of bidding document non-refundable fee of NRs. **10,000** in the following Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at **Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu** at **11:00 AM** on **15-Jul-2026**.
7. Electronic bids must be submitted through PPMO's e-GP system **www.bolpatra.gov.np/egp** on or before **12:00 Noon** on **28-Jul-2026**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM** on **28-Jul-2026** at the office of **Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu**. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 34,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
