Invitation of Bids for: Interior Furnishing and Finishing works for Newly Constructed Buildings at Nepal Rastra Bank, Baluwatar

1. *Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu* invites electronic bids from Nepalese eligible bidders for construction of *Interior Furnishing and Finishing works for Newly Constructed Buildings at Nepal Rastra Bank, Baluwatar* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 27,10, 00,000.00**
 - Minimum Work experience of similar size and nature: as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract within the last ten (10) years, with a value of at least **NRs. 10,83,00,000.00**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
 4. Bidder shall download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit non-refundable fee of bidding document **Rs.10,000.00** in the account as specified below.

5. Pre-bid meeting shall be held at **Nepal Rastra Bank Assets and Service Management Department, Baluwatar, Kathmandu** at **11:30 AM** on **2082/10/09**.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon** on **2082/10/19**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' authorized representative who choose to attend at **1:00 P.M.** on **2082/10/19** at the **Nepal Rastra Bank Assets and Service Management Department, Baluwatar, Kathmandu**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum to **NRs. 40,00,000.00 (In Words: Forty Lakhs Only)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2083/03/19**)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Nepal Rastra Bank reserves the right to accept or reject any bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to Bidders.
