- 5. Quotations must be valid for a period of **45 days** from the last date of submission of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee which shall be **valid for 75 days** from the last date of submission of Sealed Quotations (i.e. till 2076/12/04).
- 6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No 180999/011-001-524 at Nepal Rastra Bank, Pokhara Office and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotation shall be opened in the presence of supplier's authorized representative who choose to attend at 12:30 PM on 2076/09/18 at the Nepal Rastra Bank, *Pokhara Office*.
