Invitation for Bids for the Construction of Guest House Building at Nepal Rastra Bank, Siddharthanagar, Rupandehi

Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu invites electronic bids from eligible bidders for the Construction of Guest House Building at Nepal Rastra Bank, Siddharthanagar, Rupandehi under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best three (3) years within the last ten (10) years: *NRs 9, 85, 00,000 without VAT.*
- Minimum Work experience of similar size and nature: One (1) residential or commercial building within the last ten (10) years, with a value of at least NRs 7, 90, 00,000 without VAT.
- 1. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate bids, one (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
- 2. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
- 3. A complete set of Bidding Documents may be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit non-refundable cost of bidding document Rs.10,000 in the account as specified below. - 4. Pre-bid meeting shall be held at Nepal Rastra Bank General Services Department, Baluwatar, Kathmandu at 12:00 noon on 2076/08/15.
- 5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2076/08/25.
- 6. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 13:00 P.M. on 2076/08/25 at the Nepal Rastra Bank General Services Department, Baluwatar, Kathmandu. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum to Rs 2,500,000 (In Words: Rs Two Million Five Hundred Thousand Only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077/01/27)
- 7. If the last date of submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
