- 1. Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu invites *electronic* bids only from eligible bidders for The Procurement of Supply, Delivery, Installation, Testing and Commissioning of Generators under National competitive bidding – Single Stage Two Envelope procedures.
- 2. The bidder may submit the bid for single or more packages as mentioned below and offer discounts/cross discounts, if any, in Letter of Price bid. Evaluation will be done for each package, with contracts awarded based on the award combination that is of least cost to the Purchaser.

- 3. Under the Single Stage, Two Envelope Procedure (eGP), Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the bidding documents at PPMO eGP system <u>www.bolpatra.gov.np/egp</u>.
- 5. Bidders shall download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should submit their bid electronically and should deposit the cost of bidding document in the following account as specified below.

- 6. Pre-bid meeting shall be held at Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu, Nepal at 2082/04/22 at 12:00 Noon.
- 7. Electronic bids must be submitted to the office Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 11:00 AM on 2082/05/01. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:00 Noon on 2082/05/01 at the office of Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu, Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as mentioned above which shall be valid for 30 days beyond the validity period of the bid (i.e. 2082/08/29)
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
