Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu invites electronic bids from Nepalese eligible bidders for the Installation of concertina wire at the existing boundary wall of Nepal Rastra Bank Thapathali Office Building under National Competitive Bidding procedures. The estimated amount for the works is Rs 24,99,008.66.

- 4. Pre-bid meeting shall be held at *Nepal Rastra Bank*, *Baluwatar* at 12:05 PM on 2025/09/25.
- 5. Electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before <a href="https://doi.org/12.00">12:00 PM</a> on <a href="2025/10/09">2025/10/09</a>. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2025/10/09 at the office of Nepal Rastra Bank, Baluwatar. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of Rs.55,335.19(In Words: Rupees Fifty Five Thousand Three Hundred Thirty Five and Nineteen Paisa) which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 8. Nepal Rastra Bank reserves the right to accept or reject any bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to Bidders.
- Note:- All the bidders are requested to follow the Standard Bidding Document revised by PPMO on June 2025 for the necessary bidding document forms and apply the bid only through the e-GP system of PPMO.
