5. Sealed bids must be submitted to Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu through e-GP system i.e www.bolpatra.gov.np/egp on or before 12:00 hrs on 2026-07-31. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2026-07-31, 13:00 hrs at the office of Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NPR 15,000.00, which shall be valid for 30 days beyond the validity period of the bid 2026-10-14. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1109901/011/203/524 at Nepal Rastra Bank, Banking Department, Thapathali, Kathmandu and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
