The bids will be opened in the presence of Bidders' representatives who choose to attend at 2026-09-07, 13:00 hrs at the office of Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NPR 15,000.00, which shall be valid for 30 days beyond the validity period of the bid 2026-11-20. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1109901/011/203/524 at Nepal Rastra Bank, Banking Department, Thapathali, Kathmandu and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
