The bids will be opened in the presence of Bidders' representatives who choose to attend at 2082/02/20 13:00 hrs at the office of Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu. Bids must be valid for a period of 45 days (i.e.2082/04/02) after bid opening and must be accompanied by a bid security amounting to a minimum of NPR 40,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e.2082/05/01).
