Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 2082/12/20 (April 3, 2026)** at the office of Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu.

Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **Rs.20,000**, which shall be valid for 30 days beyond the validity period of the bid i.e. **2083/03/03 (June 17, 2026)**.
