- If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No 2109999/011/002/524 at Nepal Rastra Bank, Nepalgunj Office, Banke and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
