2. The estimated amount for the works is **5,048,640.65** (exclusive of VAT).

A complete set of bidding documents may be purchased from the above office or the office of Nepal Rastra Bank, Banking Office, Thapathali Kathmandu from 2071-03-10 to 2071-04-07 on office hours by eligible Bidders on the submission of a written application and upon payment of a non-refundable fee of **Rs.1000.00**. If the bidders submit the bid documents downloaded from web site, they should submit the bid fee along with the bids before submitting to the concerned NRB office.
5. Bids must be submitted to the above office of General Services Department, Nepal Rastra Bank, Baluwatar, and Kathmandu on or before **12:00 noon on 2071-04-08**. Documents received after this deadline shall not be accepted.
6. Pre-bid meeting shall be held at General Services Department (GSD),Nepal Rastra Bank, Baluwatar, Kathmandu,on 2071-03-31 at 02:30 pm
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 02:30 pm on **2071-04-08** at the office of General Services Department, Nepal Rastra Bank, Baluwatar, Kathmandu.
8. Bids must be valid for a period of **90 days** from original bid submission date and must be accompanied by bid security, amounting Rs: 1,71,200.00 which shall be valid for **30 days** beyond the bid validity period.
9. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No. **110-9901/011.000.524** at **Nepal Rastra Bank, Thapathali, Kathmandu** and submit the receipt of the deposited amount of cash along with the bid.
10. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
11. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
